Description

The SMSA3923-011LF plastic-packaged Schottky diode is designed for several automotive in-vehicle applications.

The Pb-free symbol or "LF" in the part number denotes a lead-free, RoHScompliant package unless otherwise noted as Green™. Tin/lead (Sn/Pb) packaging is not recommended for new designs.

Electrical and Mechanical Specifications

The absolute maximum ratings of the SMSA3923-011LF are provided in Table 2. Electrical specifications are provided in Table 3. The associated SPICE model parameters are provided in Table 4.






Figure 1. SMSA3923-011LF Total Capacitance vs Reverse Voltage

Typical performance characteristics of the SMSA3923-011LF series are illustrated in Figure 1. Package dimensions are shown in Figure 2, and tape and reel dimensions are provided in Figure 3.

Package and Handling Information

Instructions on the shipping container label regarding exposure to moisture after the container seal is broken must be followed. Otherwise, problems related to moisture absorption may occur when the part is subjected to high temperature during solder assembly.

The SMSA3923-011LF is rated to Moisture Sensitivity Level 1 (MSL1) at 260 °C for 5 seconds. It can be used for lead or lead-free soldering. For additional information, refer to the Skyworks Application Note, *Solder Reflow Information*, document number 200164.

Care must be taken when attaching this product, whether it is done manually or in a production solder reflow environment. Production quantities of this product are shipped in a standard tape and reel format.
