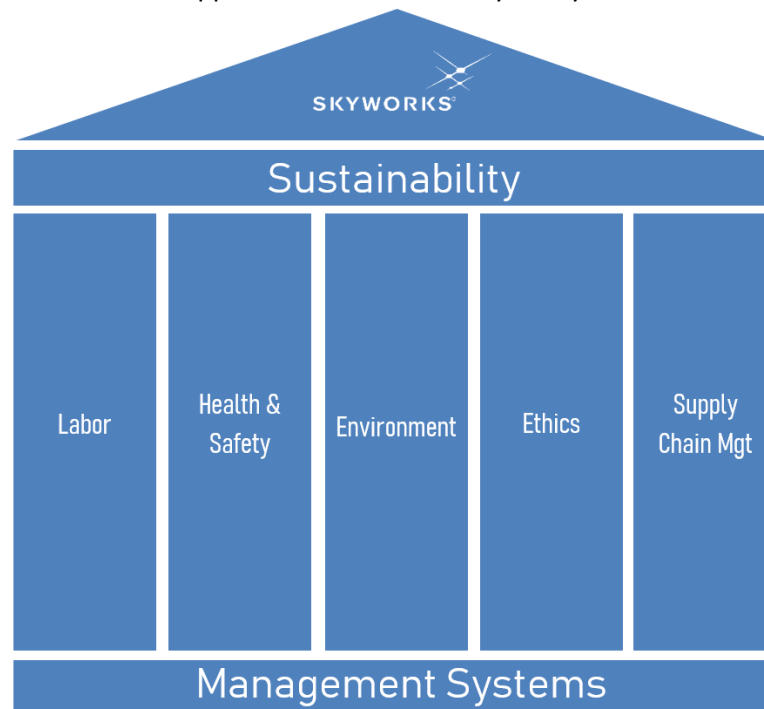
## 6 Leadership and Commitment

Skyworks operates a company-level corrective and preventative action process by which nonconformities to sustainability program requirements are systematically addressed through root cause analysis and corrective/preventative actions.

### 10.4 Management Review

In order to ensure the sustainability system's continuing suitability and effectiveness, management periodically reviews the performance of the sustainability systems, at planned intervals. Management reviews are documented along with outputs from the review process including but not limited to conclusions about the sustainability systems, decisions regarding continuous improvement, decisions related to any need for changes, actions taken or needed, opportunities to improve integration of the sustainability systems with other business processes, and any implications regarding Skyworks' strategic direction.

## 11 Training and Awareness

Employees and contractors working at Skyworks locations are appropriately trained according to their job responsibilities to the provisions of this Sustainability Systems Manual and its supporting programs.
